Richland County Council is holding a public hearing on funding public transportation for the next 20 years. Council is proposing an additional county-wide penny sales tax for roads, buses and pathways. We support the penny tax, but strongly believe that the bus system and DART are being under-funded.

Council's own consultant recommended 60% for roads, 33% for public transit and 7% for pathways. Council is proposing a formula that gives roads 71%, public transit 25% and pathways 4%.


Since roads have other sources of funding and public transit and pathways are always underfunded, Council should put the consultants' funding formula on the November ballot.

Come to the hearing, or contact your County Council representative (contact info on back) and tell them to fund a modern public transit that will:

- Create jobs and stimulate economic growth
- Reduce our dependence on foreign energy
- Ease congestion on our highways
- Protect the environment
- Dramatically increased frequency of service, longer hours and effective feeder routes
- Improve the quality of life for everyone.
