Bill Fletcher, Jr., to speak at Progressive Network's annual statewide retreat at Penn Center Oct. 3-4



Longtime labor and racial justice activist Bill Fletcher, Jr., will join SC progressives Oct. 3.

Then grassroots activists from across the state gather at Penn Center for the Network's 14th annual fall retreat, they will get the chance to hear Bill Fletcher, Jr., one of the nation's leading progressive strategists, speak about the current political climate and what that means for organizers.

"When it comes to both theory and practice, Bill Fletcher is the sharpest knife in the drawer," said Network Director Brett Bursey. "He has the rare gift of cutting through the fog and illuminating the path. He clearly identifies the problems and poses insights, tactics and strategies for solving them."

The weekend gathering is an opportunity for SC activists to map strategy, sharpen organizing skills, reconnect with allies and recharge their batteries.

Network to release racial disparities study

The SC Progressive Network produced a study in 2000 that found the arrest rates for black South Carolinians to be among the world's highest. Nearly 10 percent of the entire black population is arrested every year. White arrests in South Carolina are below 4 percent, slightly above the national average. (By contrast, rates in every other civilized country are below 1 percent).

The Network subsequently sponsored legislation designed to identify and inhibit racial profiling by requiring all cops to report all stops. The bill, which required the Dept. of Public Safety to post the information online, passed in 2006, attached to the mandatory seat belt bill.

In April 2009, when DPS regulations to implement the bill went before a Senate committee for approval, we learned that the wording was changed in conference committee. The statute now requires cops to report only "noncustodial" stops, or warning tickets.

Network's push for public Internet service in SC addressed in critical legislative hearing

Athree-hour meeting of a legislative subcommittee Aug. 5 gave opponents of privatizing SC ETV's broadband spectrum their first opportunity to challenge the contract that privatizes the system.

The SC Progressive Network presented testimony that the state should retain control of 25 percent of the spectrum for public use. This "mid band" portion of the spectrum would allow robust wireless Internet statewide.

The contract now under consideration could result in the public losing control of the nation's only unified, statewide broadband system.

The subcommittee, comprised of Sen. Glenn McConnell, Sen.
Harvey Peeler, Rep. Gilda CobbHunter and Rep. Dan Cooper, decided that further study of the contract terms were necessary.

The proposed contract leases the statewide educational broadband system to Clearwire and Digital Bridge for 30 years.

Peeler and Cobb-Hunter, who represent rural counties, were concerned that

the contract doesn't require the companies to provide service in rural and underserved areas.

Sascha Meinrath, Director of New America Foundation's Open Technology Initiative, testified and responded to questions regarding the practicality of adopting the system for public access. Meinrath's participation provided the Network with the necessary technical background and analysis of the issue. Meinrath's comments on the historical under-valuation of public airwaves was of particular interest to the subcommittee.

McConnell, chair of the subcommittee, gave all interested parties an opportunity to submit additional information on the value and benefits of public retention of 25 percent of the spectrum.

Meet Bill Fletcher, Jr.

Bill Fletcher, Jr., is Executive Editor of *The Black Commentator* and founder of the Center for Labor Renewal. A longtime labor, racial justice and international activist, he is past president of TransAfrica Forum, a national nonprofit organization organizing, educating and advocating for policies in favor of the peoples of Africa, the Caribbean and Latin America. He is a founder of the Black Radical Congress and is a Senior Scholar for the Institute for Policy Studies.

Fletcher got his start in the labor movement as a member of the Industrial Union of Marine and Shipbuilding Workers of America. Combining labor and community work, he was also involved in ongoing efforts to desegregate the Boston building trades. He later served in leadership and staff positions with the United Auto Workers, National Postal Mail Handlers Union and Service Employees International Union (SEIU). He is currently the AFGE Director of Field Services & Education Department.

Fletcher is co-author of *Solidarity Divided, The Crisis in Organized Labor* and *A New Path Toward Social Justice*. He is a graduate of Harvard University, has authored numerous articles and speaks widely on domestic and international topics, racial justice and labor issues. \blacktriangledown

"Requiring only warning tickets to be recorded guts the intent of this legislation," said bill sponsor Rep. Joe Neal. "Police should be willing to divulge the race of the more than 2 million drivers who get tickets every year."

The Network, with the assistance of an intern from the USC Women and Gender Studies Department, has reviewed the most recent arrest rates and DPS' implementation of the system to track warning tickets.

"Arrest rates for black South Carolinians since 2000 are still double what they are for whites," said Network intern Kathryn Witzke. "We found that the system to track racial disparities in warning tickets is ineffective at best and violates the statute at worst."

Of the 295 police agencies in SC that are supposed to be filing monthly reports on the race and gender of non-custodial stops, only 71 are in full compliance, and 80 have never filed since the system became mandatory in July 2008.

The Network will publish the results of the new study this fall. "We will insure that citizens and local officials in the jurisdictions of the 224 police agencies who are breaking the law get a copy of the report," Neal said.
